## Makeup & Hair Styling Agreement

**Bookings:** All bookings and details will be arranged with and confirmed by Bride/Client and Make Up Artist, Rachel Eden. Your appointment date and service will be secured when the signed contract and non-refundable deposit of services is received. A makeup consultation/trial is part of the bridal package and is required.

**Travel Fee:** Travel is included in pricing for Nanaimo city limits only. Outside this radius, a travel fee will apply. If so, that will be settled by agreement in an email between the Bride/Client and Rachel Eden. **TRAVEL FEES MUST BE PAID IN ADVANCE OF THE EVENT.** 

**Payment:** Payments can be made by cash, e-transfer, or with debit/credit card at event. A non-refundable 50% deposit for all services is required at the time of booking. This secures your wedding/event date, the time to allow for makeup services for your wedding party and covers your bridal consultation (bride only). The final balance of services is due on the day of your wedding/event before leaving. Additional Charges: parking/valet/ferry/travel fee must be paid with the deposit. If you decide to cancel the booking (see cancellation policy below) the additional travel fees will be refunded in full but not the deposit.

\*\*\*The agreed upon payment is the fee for services and does not include gratuities which are gratefully accepted\*\*\*

If, on the day of your event, there are extra services required, IE: additional friends, family that have not been scheduled, they MAY be able to be accommodated, if I have time in my schedule. These services <u>MUST</u> be paid for prior to application, no exceptions.

Cancellation: Your booking is a reserved spot and as such, deposits are non-refundable. We are well into a year of the current pandemic and as such, should be taken into consideration when planning your event. Given this, there will be no refunds if governing regulations allow for events but you choose not to move forward. Cancellations must be made, in writing, at least 60 days in advance of your booked wedding/event date. If you do not submit your cancellation notice at least 60 days in advance, the outstanding balance must be paid in full. **No Exceptions.** 

**Service Location and Requirements:** The location of makeup services for the day-of-event will be at the Bride's/Clients discretion, but there are certain requirements the artist will need to complete the services. A set-up table/work area/chair/trashcan/outlet- will need to be available for the Makeup Artist. Ample lighting, whether by means of natural light or by lamps, is necessary for services to be performed properly. Artist will arrive 15 minutes prior to set-up. Please communicate the hotel room number if applicable by email or text. All brides are required to attend a **mandatory consultation** in my studio.

**Delays:** <u>Please be prepared to start when I arrive</u>. All ladies receiving makeup must have a clean face and be ready to start. This is very important, so we can stay on schedule, and I can finish applications in the allotted time.

Social Media and Website: Photos taken at the trial and/or your professional photos may be included in my portfolio for future
clients to view. Your photographer will receive proper credit for their work. If you agree to me using these photos, as well as give
consent to using your professional photos on my website/portfolio/social media, please indicate consent below by initialling

**Liability:** I take hygiene seriously. All makeup products and brushes are kept sanitary. All products are sanitized between every makeup application. Any skin condition MUST be reported prior to the application. I only use my own equipment and product and I am not able to razor eyebrows – but I am able to tweeze as required. (I will take into consideration using your product for lip applications only.) Client agrees to release the artist from liability for any skin complications due to allergic reactions.
